AFFIDAVIT IN SUPPORT

I, FRANCIS ANKOMA-SEY of H/No. C 688/3 Kaanyemi Crescent Asylum Down, Accra do hereby make oath and say as follows:

1. That I am the deponent herein.
2. That I am the law clerk in the law offices of Nkrabeah and Associates.
3. That I have the authority of the Applicant to swear to the facts in this affidavit on his behalf.
4. That the facts are sufficiently known to me.

5. The 1st respondent is counsel for the Plaintiff in this matter.
6. The 2nd Respondent is the presenter of a programme known as Ghana Kasa on Kasapa FM, a radio station operating in Accra.
7. That in the year 2022 the Plaintiff herein issued a writ of summons against the defendant.
8. That even though the matter has been pending in this honourable court the 1st respondent uses every opportunity to use the processes of this court to threaten, disrespect and verbally abuse the Applicant in the matter on television and on radio.
9. That very recently he was seen and heard using the 2nd Respondent's platform, a programme called Ghana Kasa on Kasapa FM, stating that he has used the processes of this honourable court to tame the uncouth "Afia Schwarzenegger. Attached is a video of the said programme and a subsequent article on same published by GhanaWeb marked as Exhibits A and A1.
10. That as an officer of this court the 1st respondent's actions are reprehensible and calculated to prejudice the outcome of this pending matter before this honourable court.
11. That the 1st respondent ought to know that insinuating that he is using this court as his personal tool to exact revenge and discipline people he is not ad idem with is an affront to the dignity of this honourable court.
12. That such pronouncements from the 1st Respondent in the ears of well-meaning Ghanaians suggest this honourable court has no autonomy and can be manipulated to suit the 1st respondent's whims and caprices.
13. That the 2nd respondent ought to have known not to give his platform to the 1st respondent and allow him to publish such contemptuous language and content about this honourable court to the good people of Ghana.

14. That the 1st respondent as an officer of this court also went on to use the 2nd respondent's platform to threaten, bully and cajole 'enemies and critics of his client the Plaintiff in this matter.

15. That the respondents have shown no remorse or repentance but instead have demonstrated a strong resolve to continue to use this court to conduct their personal vendettas, prejudice and ongoing matter and bring the name and proceedings of this court into disrepute.

16. Accordingly, I swear to this affidavit praying that for showing gross disrespect and disregard to the proceedings of this honourable court, the two Respondents should be convicted for contempt of Court and sent to Prison to serve as deterrence to others to uphold the rule of law.

17. Wherefore I swear to this affidavit in support of the application.

I've tamed uncouth Afia Schwarzenegger; she is now a responsible girl – Maurice Ampaw brags



Afia Schwarzenegger is a popular Ghanaian

According to him, he has been able to singlehandedly tame the popular socialite, adding that he has transformed her from being ill-mannered to a refined lady.

Maurice Ampaw argued that after he scared Afia with a lawsuit which resulted in a 10-day court sentencing, she has since been humbled, particularly after rendering an apology to the court to ease her judgement.

"I have humbled Afia Schwarzenegger a point where she is now a good girl. Afia who was very uncouth and disrespectful is now a very good and responsible girl. I have straightened her. I was able to achieve that by scaring her with the previous court sentence. She had to run to the court and beg," He stated in an interview with KasapaFM.

Touching on his incessant habit of fighting Chairman Wontumi's detractors which includes Afia

Schwarzenegger, Maurice Ampaw established,

"Anyone who has ever insulted chairman Wontumi should prepare for court summons. For instance, in this Ashanti issue, we will sue everyone who has misbehaved. People who sit behind the console and spew rubbish should be ready. They will answer in court."

Afia Schwarzenegger and Lawyer Maurice Ampaw have since been at each other's throats following the former's legal tussle with Bernard Antwi Boasiako popularly known as Chairman Wontumi, the Ashanti Regional Chairman of the ruling New Patriotic Party (NPP).

The legal battle started in 2022, after Afia Schwarzenegger claimed to have had an amorous relationship with Chairman Wontumi and made other allegations against him.

Following her submissions on UTV, she and four other UTV panelists were sued by the NPP Ashanti regional chairman, for allegedly making derogatory marks about him live on air.

Each panelists paid their GHC60,000 fine except Afia Schwarzenegger who resisted her arrest after the court issued a bench warrant.

She failed to show up at any of the court proceedings, a situation that caused the court to slap her with another charge of contempt, where she was sentenced to a 10-day jail term.

Afia resisted the arrest and continued to reside at her hangout until she eventually turned herself in, sometime in February 2023.

After a series of proceedings, she was fined GHc60,000 by the Tema High Court in the contempt case and also ordered an additional GHc5,000 fine to be paid to the NPP Ashanti Regional Chairman.

After submitting a remorseful apology, the court then ordered Afia Schwarzenegger to sign a bond of good behaviour for 36 months and was also ordered not to make any pronouncements or comment on the case during the bond period.
